Some basic definitions

Hazards:

Any source of potential harm. In the case of COVID-19 this is, put simply, contracting the illness as a result of exposure to infection.

Risk:

The chance or likelihood that a person will be harmed if exposed to an identified hazard. Again, in the case of COVID-19 this means the chance or likelihood that someone will be infected.

Control:

An action or measure that reduces the risk (i.e. reduces the likelihood). Controls are used to mitigate (reduce) risk.

Risk Assessment: A systematic way to identify hazards, assess the risk and identify controls to reduce the risk.

Vaccines and Risk

There are 3 key things to consider when considering the efficacy of vaccines

- 1: The likelihood of the person who has been vaccinated contracting the disease (and the potential implications/ramifications clinically if they do) – “Breakthrough Cases”
- 2: The likelihood of the person who has been vaccinated carrying and spreading the disease
- 3: New variants against which vaccines may be much less effective?

“Tests” for Englands roadmap

There are 3 key things to consider when considering the efficacy of vaccines

- 1: The vaccine deployment programme continues successfully.
- 2: Evidence shows vaccines are sufficiently effective in reducing hospitalisations and deaths in those vaccinated.
- 3: Infection rates do not risk a surge in hospitalisations which would put unsustainable pressure on the NHS.
- 4: The government’s assessment of the risks is not fundamentally changed by new Variants of Concern.

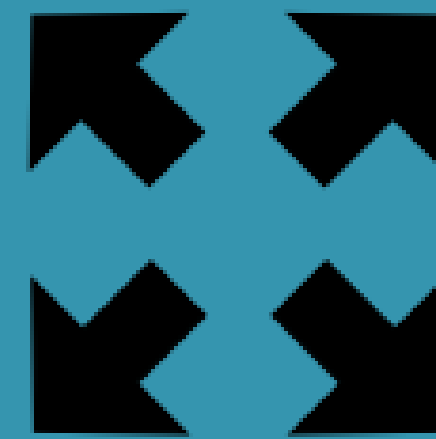

Factors for consideration

- 1: Risk to local population health?
- 2: Is the event permitted at the relevant Step of the Roadmap?
- 3: Is it an event that is subject to restrictions?
- 4: Has the event organiser carried out a comprehensive risk assessment?
- 5: Has the event organiser taken into account the relevant COVID-secure guidance?
- 6: Can/will all mitigations be operated effectively?
- 7: What will be the impact on the local area and other adjacent areas?
- 8: Has the event organiser engaged appropriately with neighbouring businesses, transport operators and local police?
- 9: Enough local accommodation providers in the area in the event of overnight stays? Has
- 10: impact of increased footfall on the surrounding area and infrastructure?
- 11: Will attendees primarily local, or a national or international audience for the event?
- 12: Has the event organiser successfully run their event in line with COVID-secure guidance previously?

SLIDE 4: GUIDANCE

Outside Vs Inside

Key reference point is the requirement for smoking shelters contained within the Smoking (Northern Ireland) Order 2006

If a structure is wholly or substantially enclosed it is **indoor**.

At least 50% of the structure must be open

Regulation and enforcement

EH Departments in Councils – not H&SENI

Talk to them – early – they will help you run your event as safely as possible and in compliance with requirements

Summing up – the “new normal”

- Risk assessment – additional scope and even more importance
- RA is unique for every event – there is no “off the shelf” kit
- Increased scrutiny from both Regulators and the general public. (Due Diligence)
- Increased responsibilities on venue owners and organisers. Duty of care not only for staff but for customers/the public. If there is a case (or worse outbreak) what are the liabilities?
- Controls around ventilation (indoor events); social distancing; maximum capacity; hygiene requirements all likely to be required (ie legally)
- Testing and tracing (ie the need to retain details of those attending an event likely to also be specifically required - summarise requirements for England by way of example)
- Vaccine deployment programme continues successfully.

What is a Contingency Plan?

... a plan designed to take account of a possible future event or circumstance. (Oxford Dictionary)

In the context of event planning.

- A plan designed to mitigate risks arising from future circumstances which can not be controlled by the event organiser.
- A plan which can be strategic, operational, financial or a combination of all three.



Americas Cup 2021

Case Study – 36th Americas Cup, Auckland New Zealand 2021

Case Study – 36th Americas Cup, Auckland New Zealand 2021

- 1** Event took place and was completed within original schedule
- 2** There was no prospect of Level 0 (borders open) during the event
- 3** Auckland experienced Level 1, 2 and 3 during the event.
- 4** Level 3 led to postponement of race days. Level 2 led to limitations on Event Village capacity
- 5** Event delivered on budget
- 6** Extensive use of Track and trace App in population
- 7** No Covid-19 cases connected to the event

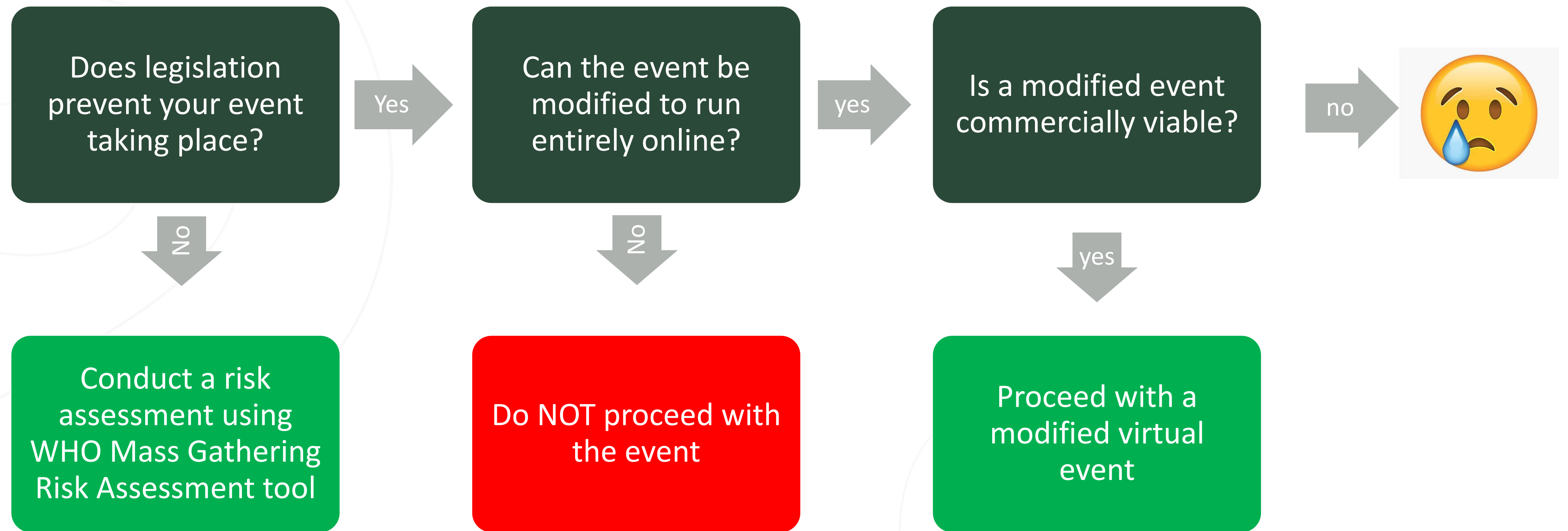

The guidance is designed to cover all mass gatherings and builds on work with both the International Olympic Committee and International Football (FIFA).

In brief

- Tool is scalable, all sections may not be relevant to your event
- The 'Risk Assessment' section is short and easy to undertake, generating a 'Risk Score'
- The 'Risk Score' can be improved by accepting 'Mitigating Actions' from a very long list of possible actions
- Some Mitigating Actions are not relevant to smaller scale events or to domestic only events
- The list of 'Mitigating Actions' agreed to can be exported to create an action plan.
- A separate assessment is required for each contingency plan level.
